The new **Candidacy Mentorship Program (CMP)** provides graduates of accredited social work schools with a strategic, supportive, and educational professional development experience rooted in principles of adult learning. New graduates and those re-entering practice (candidates) are linked with with experienced practitioners (mentors). Candidates gain valuable support throughout their 2500 hours of practice through regular, structured, and documented meetings with their mentor.

All candidates who began their Candidacy requirements before September 1st, 2018 may continue under the old framework. Candidates who are transitioning to the new CMP must complete the steps in this application.
