CONSENT CONTEMPT ORDER

JAK, J.

BEFORE THE HONOURABLE JUSTICE KEITH IN CHAMBERS:

WHEREAS the Honourable Justice John A. Keith issued a permanent injunction order against the Respondent, Leanne (Dawn) Archambault ("**Ms. Archambault**"), on December 20, 2021 (the "**Permanent Injunction Order**");

AND WHEREAS the Applicant, Nova Scotia College of Social Workers (the "**College**"), commenced an Application in Chambers to find Ms. Archambault in contempt of the Permanent Injunction Order;

AND WHEREAS counsel for the College, Ryan Baxter and Jeremy Ryant, and Ms. Archambault, on behalf of herself, appeared before the Court on September 1, 2022 for the hearing of this Application;

AND WHEREAS during this hearing, Ms. Archambault:

- (a) confirmed that she accepted responsibility for the contemptuous acts alleged by the College in the materials filed with this Application (the "**Contemptuous Acts**");
- (b) admitted that she intentionally committed the Contemptuous Acts in deliberate breach of the Permanent Injunction Order; and
- (c) understood and accepted that the consequences of making such admissions were that the Court would find her in contempt of the Permanent Injunction Order and that a penalty hearing would follow;

IT IS THEREFORE DECLARED that the Court is satisfied beyond a reasonable doubt that Ms. Archambault is in contempt of the Permanent Injunction Order;

the College's Application is granted;

a hearing for the penalty phase of this Application will be heard at the Law Courts, 1815 Upper Water Street, Halifax, Nova Scotia on Friday January 6, 2023 at 9:30 a.m.;

two pre-penalty hearing conferences will take place via teleconference on Monday October 3, 2022 at 9:30 a.m. and Thursday October 27, 2022 at 2:00 p.m.; and

Ms. Archambault shall pay costs of this Application to the College in the cause, in an amount to be determined at the January 6, 2023 penalty hearing.
